

# Pacific Propane Gas Association Smart-Hose Safety System Program Rules and Regulations

**WHO AND WHAT IS ELIGIBLE?** Rebates are available to propane marketers who reside in Alaska, Hawaii, Oregon and Washington and who purchase eligible Smart-Hose Safety System facility hoses.

**WHAT HOSES ARE ELIGIBLE?** The incentive will be \$500 per qualified Smart-Hose Safety System. This project is budgeted to fund 50 incentives for facility hoses only. Generally, a facility will have 1 to 2 loading racks/bulkheads. Each loading rack/bulkhead will need one 2" and one 1 1/4" hose. Rail towers and transports will not be eligible.

Eligible products have been determined to be: DOT Certified 2" LPG Smart-Hose (LL3) and (LL3-B) DOT Certified 1 1/4" LPG Smart Hose (LL-3) and LL3-B).

**WHEN DOES THE PROGRAM BEGIN AND END?** The rebate program begins January 1, 2020 and ends December 31, 2020, or when program funds are exhausted. The payment of a rebate under the program or this agreement is subject to available funds. If available funds run out during the program year, PPGA may elect to carry over applications until the next program year. All eligible purchases must occur during the rebate program.

Completed and approved applications should have a rebate check issued within 60-90 days after the application is received at the PPGA office, subject to available funds. No applicant has a legal right or other entitlement to receive rebates under the program or this agreement. A completed application does not bind PPGA to approve or pay a rebate to any applicant.

An applicant may be suspended from, or declared ineligible to participate in the rebate program if the PPGA determines that the applicant or propane marketer has submitted false information or otherwise violated program terms and conditions. Within 30 days after PPGA suspends or declares an applicant or propane marketer ineligible, the applicant or propane marketer may appeal the action by submitting the appeal in writing to PPGA. Actions taken by PPGA with respect to the appeal will be final. An applicant or propane marketer who submits false information pertinent to a rebate is subject to criminal and civil penalties including U.S. Mail fraud.
